Action Plan Steps

- 1. ACT prep classes will be taught three times per year. October, December and February.
- 2. ACT for all sophomores who want to take it during their sophomore year.
- 3. Science department supplies to include hands-on activities for students to learn from.
- 4. IXL, AR, ALEKS software for teachers to incorporate in their classes.
- 5. Up-to-date technology for teachers to improve their teaching and calculators for students to improve math scores.
