- Marcia Anderson's wage is paid 40% by lunch money and the other portion comes from the School Trust. Committee in agreement to continue as in the past.
- Our school musical is currently allotted \$3000. We have the option to increase the amount.
- We are a "Targeted School" in the area of the 2nd language students in the 3rd and 4th grades. ESL test scores are low and not making the desired progress. What is being done to help-Our Analili is in the classrooms helping students and is in contact with parents of these students. Even after school hours.
