It was reported to the Members of the Board that the Millard School District 2014 Jacobsen Lawn Mower caught on fire while sitting parked at the Millard School Bus Garage on Monday morning, September 16, 2019. The cost of replacing this unit with a new 2019 Jacobsen Lawn Mower is \$63,152.22. Utah State Risk Management has paid \$27, 850 to the Millard School District for the insurance claim. This represents the estimated replacement value of \$28,850 less the \$1,000 deductible.
