#### Consideration of One-Time Retirement Benefit for Health Insurance

One-Time Window Benefit for Health Insurance

Discussion was held regarding the Millard School District offering a one-time only Retirement Benefit for health insurance. The summary of the major parts of this offering are as follows:

This is a one-time opportunity for the 2019-2020 school year only, after which the District will evaluate the positive and negative effects of this practice before determining the feasibility of continuing such a benefit.

These funds are to be used exclusively for the purposes of providing health insurance coverage to eligible employees who wish to retire and their eligible beneficiaries.

Those wishing to take advantage of this opportunity must inform the District on or before January 15, 2020 for retirement benefits.

This benefit may be used only in place of and not in addition to the current retirement benefit that is in Millard School District Policy 4016.

The insurance benefit, whether for the employee or a beneficiary, ends at age 65 or premiums paid that total \$60,000. Upon all beneficiaries reaching age 65, all remaining funds from this benefit are forfeited.

This benefit is available for all insurance eligible employees of the Millard School District.

The current premiums paid by the District for PHD 2700 health insurance are as follows:

Single - \$8,652 / year Employee + One - \$19,032 / year Family - \$27,036 / year

Premiums will likely increase each year, but the benefit remains constant. There is no guarantee that these funds will be sufficient to cover future insurance costs without supplementation by the individual.

Member Barney made a motion to approve a one-time only retirement benefit option for health insurance, as outline above, seconded by Member Rawlinson and carried unanimously by the Members of the Board.
