#### **RESOLUTION OF GOVERNING BODY**

A resolution approving the form of the Lease/Purchase Agreement and the Base Lease with ZIONS BANCORPORATION, N.A., Salt Lake City, Utah and authorizing the execution and delivery thereof.

Whereas, the Millard School Board (the "Governing Body") of the Millard School District (the "Lessee") has determined that the leasing and subleasing of the property described in the Lease/Purchase Agreement (the "Lease/Purchase Agreement") and the Base Lease (the "Base Lease") presented at this meeting is for a valid public purpose and is essential to the operations of the Lessee; and

Whereas, the Governing Body has reviewed the form of the Lease/Purchase Agreement and the Base Lease and has found the terms and conditions thereof acceptable to the Lessee; and

Whereas, either there are no legal bidding requirements under applicable law to arrange for the leasing and subleasing of such property under the Lease/Purchase Agreement or the Base Lease, or the Governing Body has taken the steps necessary to comply with the same with respect to the Lease/Purchase Agreement and the Base Lease.

Be it resolved by the Governing Body of the Millard School District as follows:

SECTION 1. The terms of said Lease/Purchase Agreement and the Base Lease are in the best interests of the Lessee for the Leasing and subleasing of the property described therein.

SECTION 2. The appropriate officers and officials of the Lessee are hereby authorized and directed to execute and deliver the Lease/Purchase Agreement and the Base Lease for and on behalf of the Lessee. The officers and officials of the Lessee may make such changes to the Lease/Purchase Agreement, Base Lease, and related documents and certificates as such officers and officials deem necessary or desirable, such approval to be conclusively evidenced by the execution and delivery thereof.

SECTION 3. The officers and officials of the Governing Body and the Lessee are hereby authorized and directed to fulfill all obligations under the terms of the Lease/Purchase Agreement and Base Lease.

Member Barney made a motion to approve the Resolution, as presented, for the refinancing of the Millard School District Series 2012 and Series 2013 Lease Revenue Bonds and appoint Keith T. Grifiths, as "Designated Representative" for closing, seconded by Member Finlinson and carried unanimously by the Members of the Board.
