After the meeting had been duly called to order and after other matters not pertinent to this resolution (the "Resolution") had been discussed, the Secretary-Treasurer presented to the Governing Board a Certificate of Compliance with Open Meeting Law with respect to this December 14, 2023, meeting, a copy of which is attached hereto as <u>Exhibit A</u>.

It was then noted that pursuant to the Local Government Bonding Act, Title 11, Chapter 14 and Chapter 14a, Utah Code Annotated 1953, as amended, a Notice of Intent to Issue Debt and Notice of Public Hearing with respect to the issuance of the Authority's Lease Revenue Bonds, Series 2024, in the principal amount of not to exceed \$50,000,000, was posted as a Class A notice under Section 63G-30-102: (i) on the Utah Public Notice Website created under Section 63A-16-601, Utah Code Annotated 1953, as amended, (ii) on the official website of Millard School District, Utah (the "District"); and (iii) in a public location within the offices of the District that is reasonably likely to be seen by residents of the District, no less than fourteen (14) days prior to the public hearing. Such public hearing, held on the date hereof, was then opened to all members of the public desiring to give input with respect to the issuance by the Authority of its Lease Revenue Bonds, Series 2024.

After allowing for public comment, the public hearing was closed.
