The Millard County Chronicle Progress is in the process of building a mobile app to cover the activities going on in Millard County. Community members and visitors will be able to enjoy the convenience of finding much information available regarding what is happening in Millard County. Mrs. Shellie Dutson, Editor of the Millard County Chronicle Progress, indicated in the July Board of Education meeting that she would work hard to have all Millard School District activities available on this mobile app.

The cost for Millard School District to participate in having its activities on the "Experience Millard County" app would be \$250.00 per month.

Member Rawlinson made a motion to approve the Millard School District participating with the Millard County Chronicle Progress "Experiencing Millard County" app, at a cost of \$250.00 per month, on a one year trial basis, seconded by Member Holt and carried unanimously by the Members of the Board.

Utah Pioneer Heritage Arts

Utah Pioneer Heritage Arts

Utah Pioneer Heritage Arts, a 501(c)(3) nonprofit organization, is collaborating with the Friends of the Territorial Statehouse State Park Museum, another 501(c)(3) entity, to create the Old Capitol Storytelling Festival.

The two culminating events of the festival will be storytelling presentations that would need halls such as the Delta High School and Millard High School auditoriums. The Delta High School event would be held on the evening of Friday, March 23, 2018, and the Millard High School auditorium all day on Saturday, March 24, 2018. With the request being for waiver of the rental fee for these events. These activities would be free to the public.

The second request is to bring the “One Voice Children’s Choir” to Millard High School for a performance on Saturday, March 24, 2018. The request is for this choir to come in school buses rather than caravan of private vehicles. The Utah Pioneer Heritage Arts Festival would expect to pay a fee for having the school buses pickup the choir in Salt Lake City and return the choir members home after the event.

Member Holt made a motion to approve the use of the Delta High School and Millard High School auditoriums for the Old Capitol Storytelling Festival, with waiving the rental fee, and giving tentative approval for the transporting of the “One Voice Children’s Choir” to perform on Saturday, March 24, 2018, subject to working out the liability insurance for coverage for the use of the school buses, seconded by Member Rawlinson and carried unanimously by the Members of the Board.
