The Millard School District Financial Statements and Single Audit and State of Utah Legal Compliance Reports, for the Fiscal Year ending June 30, 2017, were presented to the Members of Board for review.

The Millard School District Financial Reports and Single Audit and State of Utah Legal Compliance Reports are on file at the Millard School District Office for review, as well as the Financial Statements and Single Audit and State of Utah Legal Compliance Report being on the District's Webpage at: [www.millardk12.org](http://www.millardk12.org).

A review was made of the Independent Auditor's Report, for the fiscal year ending June 30, 2017 which was furnished by Gilbert and Stewart, Certified Public Accountants. Gilbert and Stewart have audited the Millard School District financial statements of the governmental activities, each major fund, and the aggregate remaining fund balances of Millard School District (District) as of and for the year ended June 30, 2017, which collectively comprise the District's basic financial statements. These financial statements are the responsibility of District management.

In the opinion of Gilbert and Stewart, the financial statements referred to above fairly, in all material respects, represent the respective financial position of the governmental activities, each major fund, and the aggregate remaining fund information of Millard School District as of June 30, 2017, and the respective budgetary comparison for the general fund for the year then ended in conformity with accounting principles generally accepted in the United States of America.

The District is reporting under the financial model of GASB Statement No. 34. In the opinion of Gilbert and Stewart, Millard School District complied, in all material respects, with the general compliance requirements identified above and the requirements governing types of services allowed or unallowed; eligibility; matching; level of effort; or earmarking; reporting; and special tests and provisions that are applicable to each of its major state assistance programs for the year ended June 30, 2017.

The June 30, 2017 financial statements have been reviewed by the State of Utah, Office of the State Auditor, to verify substantial compliance with generally accepted accounting principals (GAAP); Government Auditing Standards; and, where possible, to verify compliance with finance-related legal and contractual provisions as set forth by State law.

Member Holt made a motion to accept the Independent Auditor's Report, provided by Gilbert and Stewart, for the Millard School District's Financial Statements and Single Audit and State of Utah Compliance Report for the year ended June 30, 2017, with the financial statements being in material compliance, seconded by Member Lund and carried unanimously by the Members of the Board.
