David Andrade, Band and Orchestra Teacher at Delta Middle School, addressed the Board regarding a variety of topics. He discussed that he will be taking over the summer band work this summer and discussed how the band and orchestra programs at the high school and middle school can better work with each other.

Board Member Comments

Board Member Comments

Member Stephenson expressed a sense of nostalgia as the school year concludes, offering his sincere gratitude for the years of service rendered by district retirees. He noted his optimism for the future as major construction projects near completion, which he believes will allow the district to focus more on strategic educational goals. He specifically highlighted the successful open house at Millard High School and thanked the taxpayers for supporting the beautiful new addition. Finally, he commended the collaboration between local government entities regarding the new property in Fillmore and thanked Ian Adams for his significant behind-the-scenes work on that project.

Member Adams shared his excitement for the graduating class, noting the great potential and excitement these students have as they move forward. He provided a technical update on the property in Fillmore recently contributed to the district, reporting that the existing sprinkler system is functional but requires a new backflow preventer and some adjustments to the heads. He explained that once the property acquisition is finalized in the coming months, the district will begin weed removal and the process of planting grass. He suggested utilizing a company currently on a state contract that has previously done high-quality work for the district to assist with the landscaping rehab.

Member George emphasized how much more the district can accomplish when everyone works together and speaks positively about their collective future. She expressed sincere thanks to the district office staff for successfully balancing the budget during a difficult year without having to implement widespread layoffs. Looking ahead, she voiced her desire for continued collaboration between teachers across the county to help one another and solve problems. She concluded by stating that the district's primary goal remains supporting its amazing communities and making great things happen for children.

Member Richins expressed her appreciation for the district office staff, specifically thanking those who handled the "extra little things" like preparing meals and organizing recognition ceremonies. She noted how much she enjoyed the recent meeting in Millard to honor retirees and celebrated the "joy and hope" seen in the eyes of the graduating seniors. Using an iceberg analogy, she remarked that while much of the board's work happens "under the water," the final product is the success and potential of the students. She closed by wishing the best of luck to all students participating in state track competitions.

Superintendent Hunter offered his congratulations to the retiring employees, praising their long-term commitment and the love they have shown for the district and its students. He reflected on the high quality of personnel within the organization and thanked the board members for their constant support. He noted that having the board's backing is essential for the district's administration to feel confident while navigating their roles. He concluded by expressing his deep gratitude for the entire district office team and the work they perform daily.

Business Administrator Holyoak stated that the day's sessions were productive and expressed his personal appreciation for the district's staff and board members.
